
A Message From THE CEO & BOARD OF DIRECTORS

An exciting announcement was made in June 2021 regarding a new YMCA for Belleville. The new YMCA Centre for Life is a partnership of five non-profit charities, led by the YMCA. Each of our partner organizations provides meaningful programs and positive relationships for the people that we serve, who, in many cases, live on a minimal fixed income. Our values and missions align, and together, we will partner to create an inclusive centre, opening the door for more people in the community to become involved in one safe, accessible, centrally located facility.

Together, with our partner organizations, Quinte Vitality & Social Support (QVSS), Volunteer & Information Quinte, Big Brothers Big Sisters of Hastings & Prince Edward Counties and Community Learning Alternatives, we will strengthen the well-being of individuals and families throughout our region and the communities we serve.

We are grateful for the early support we have received from the federal, provincial and municipal governments, as well as our community partners. The federal government is supporting the project with funding of \$8,997,000, the provincial government is contributing \$7,497,000 and land and development fees are being provided by the City of Belleville.

Located in the expanding west end of Belleville, and a five-minute walk to downtown, the 60,000 sq. ft. YMCA Centre for Life will serve the population of Belleville, Hastings County and surrounding region including Prince Edward County, Quinte West and the Tyendinaga Mohawk Territory.
